	In addition, the DAS covers: questionnaire design and online-surveys; quantitative data analysis; conducting interviews and analysing qualitative data; observation as a data collection method; group methods; valuing and reporting.

Major methods of assessment	The CAS thesis can consist of an evaluation plan, literature or empirical work or product development (e.g. an evaluation brochure to be used by the participant's organisation). For the DAS or MAS, the thesis consists of an evaluation report of the student owned evaluation project plus a critical reflection. The MAS thesis can alternatively consist of research on evaluation or a meta evaluation. The DAS and MAS contain a thesis defense.
Special characteristics of programme	The courses can also be booked separately.
Programme	The CAS aim at evaluation commissioners and evaluation managers.
	The DAS aims at evaluators. It is very much organised around an evaluation project that the participants plan and implement with the guidance of an evaluation expert. It is usually commissioned by a client (external or internal)

and conducted under real life conditions. The evaluation report together with a critical reflection constitutes the diploma thesis.

The MAS is a programme for students with extensive professional practice in evaluation and a sound theoretical background in evaluation methodology. It fosters personal and social competences of the students and supports them to reflect evaluation practice and evaluation theory on a meta level.

	We normally expect a good first degree (2.1 or 1st) or a Master's in a social science or related discipline (very broadly understood, so it includes, for example, education and business studies). We take into account not only your first degree, but also your postgrad qualifications, your other qualifications and your work experience. If you have been in work for some time, you may have built up experience in writing and undertaking research that we can take into account for admission onto the course. If you do not have a background in the social sciences or related disciplines it maybe more of challenge for you study for the MSc. The course starts from the basics of social research, but those with a familiarity with social science perspectives and issues will probably find the material easier to digest. However, we have had many students over the years from a broad range of disciplines, including the humanities, arts and computing studies and they have been successful. For applicants whose first language or language of instruction is not English you will need to meet the minimum requirements of an English Language qualification. The minimum of IELTS 6.5 overall with no element lower than 6.0, will be considered acceptable, or equivalent. You will require very good English language skills. Some of the assessments will involve the qualitative analysis of English texts and we have found that a good command of English is essential.

Core subjects of the programme	Social Research Methods and Evaluation
Major methods of assessment	Through presentation of a dissertation, normally of the order of 12,000 words. The dissertation will normally be presented to a standard format and it must be empirical. That is it must involve the collection or assembling of data collected from the world and you should analyse this data and draw conclusions from it. You would normally collect your own data, but it is possible to base a study on the re-analysis of an existing data set. Your analysis would then have to differ significantly from that already carried out with that data.
	The topic of the dissertation is something for you to decide on, though we encourage students to take up topics that are relevant to our research groups in the School. You will be assigned a supervisor for the dissertation who will have some expertise in your area and who may be someone who does not have a major teaching role in the degree.
Special characteristics of programme	The current version of the course is entirely by distance learning via the Internet. There is no requirement for students to attend in person.

	- Econometric Methods for Development
	- Welfare and Evaluation for Development - this module provides students with theoretical frameworks for evidence-based policy and a critical understanding of a broad range of issues relevant to impact evaluation and development. It reviews approaches to wellbeing and their practical application in terms of evaluating the effect of development interventions. It

	exposes students to cost-benefit analysis and considers policy and evaluation in practice looking at a range of sectors and contexts
	- Applied Methods for Impact Evaluation - this module provides students with a good basic knowledge of applied methods of impact evaluation that allows them to carry out high quality impact evaluations. For that purpose, it provides a comprehensive overview of the most important methods of impact evaluation. It provides instruction in and hands on experiences of the main quantitative and qualitative impact evaluation methods, through linked lectures and (computer) workshop/seminars.
	The remaining 3 modules can vary and are chosen based on key interests of the students. Research Techniques and Analysis is usually a very popular module with the MSc IE students.
Major methods of assessment	Written exams; dissertation (a dissertation is usually 10,000 words and it can be based on primary or secondary data).
Special characteristics of programme	We also encourage PhD applications engaging with evaluation issues and we currently have 3 PhDs students working on impact evaluation issues. We seek to grow this area.
