Responsibilities:

- Conduct the analysis of Quantitative and Qualitative data
- Develop the most rigorous research/evaluation design feasible given the context and constraints – i.e. draft and finalize the research design report including: evaluation framework, data collection instruments, data collection and analysis plans, work plans, and other relevant sections.
- Contribute to drafting project proposals, drafting protocols for Institutional Review Board clearance (as necessary), guide for data collectors and supervisors etc.
- Provide technical support and oversight of data collection, supervising survey development and implementation, and other approaches to collect and analyze data, including ensuring necessary mechanisms for data quality assurance
- Provide input on dissemination materials, such as evaluation briefs and presentation materials. Participate in dissemination efforts for the Research and/or Evaluation findings
- Ensure all evaluation processes and products meet the requirements and quality standards of both the clients as well as DMA.
- Ensure high quality effective data visualization tools and techniques both in reporting and in presentations.

Required Skills and Expertise:

- Master's degree or higher in a Social/Health science or development studies related field (e.g. Biological Anthropology, Economics, Statistics, Public Health or Policy, Political Science, or other relevant subjects)
